## 2018 Diversity Scholarship

Vedder Price recognizes the importance of diversity and inclusion at our firm. Our Diversity Committee ensures that efforts to promote and enhance diversity and a culture of inclusiveness at Vedder Price are a top priority. We established the Vedder Price Diversity Scholarship in 2005 to further our commitment to recruiting talented diverse students. This Scholarship provides a \$5,000 monetary award for law school-related expenses and a guaranteed summer associate position in our Summer Associate Program after the scholarship recipient's first year of law school.

The Scholarship has been traditionally offered in our Chicago office, and we are pleased to announce that we are adding a Scholarship position in our New York office for the Summer of 2018.

To be eligible, you must be a first-year law student who is a student of color, LGBT, a person with a disability or a person whose background or experience would otherwise contribute to the diversity of Vedder Price and the legal profession.

Chicago Scholarship: Applicants for our Chicago position must be enrolled in one of the following law schools: Chicago-Kent, Loyola University Chicago, Northwestern University, University of Chicago, University of Illinois, University of Michigan, University of Notre Dame or Washington University in St. Louis. The recipient will have the opportunity to work in our Corporate, Litigation and Labor & Employment practice areas.

New York Scholarship: Applicants for our New York position must be enrolled in one of the following law schools: American, Brooklyn, Cardozo, Columbia, Cornell, Fordham, George Washington, Georgetown, Howard, NYU or St. John's. Please note the 2018 New York position will be Corporate-focused, specifically working with our Global Transportation Finance group.
