# Diversity

We promote and support diversity within our firm by recruiting, hiring, retaining, training, developing and advancing a diverse group of attorneys and other employees on the basis of demonstrated merit and performance. Our commitment manifests itself in the development of policies and best practices to promote diversity and to engage everyone in that endeavor.

We are committed to maintaining and enhancing a diverse workforce and inclusive work environment—one that recognizes, respects and appreciates the individual differences among us and promotes both the individual success of our people and our effectiveness in serving clients to the best of our ability as an organization. Vedder Price is an equal opportunity employer. #### **Diversity Committee**

Our Diversity Committee ensures that efforts to promote and enhance diversity and a culture of inclusiveness remain a priority at Vedder Price. Chaired by Jeanah Park from 2018 to 2020 and Andy Torre from 2020 to the present, our Diversity Committee is charged with ensuring our firm reflects the rich diversity of the communities and clients we serve. To ensure that our commitment to diversity permeates all aspects of our operations, this Committee includes representatives from a broad spectrum of attorneys at our firm, including members of our Board of Directors, chairs of our Associate Evaluation Committee and Hiring Committee, our Director of Associate Development, and our Manager of Legal Recruiting.

Vedder Diverse is a formal diverse attorneys initiative at Vedder Price that supports the firm's recruitment, retention and advancement of diverse attorneys, while giving those attorneys additional opportunities to expand their practices. While focused on diversity matters, Vedder Diverse provides training and guidance to all Vedder attorneys. Vedder Diverse, with support from the Diversity Committee, sponsors programming across all offices, including networking and business development events, discussions, informational lunches and mentoring relationships. Shareholders David M. Hernandez of the Washington, DC office, Ji Woon Kim of the Singapore office, Joseph H. Kye of the Chicago office, and Andrew Torre of the Chicago office are the co-chairs of Vedder Diverse and lead activities in their respective offices.

Vedder Price's Women's Initiative, "Women at Vedder Empowering Success" or "WAVES," was created to enhance the firm's commitment to gender diversity—a key priority for us and the clients we serve. The WAVES mission is to support the firm's women attorneys in developing the skills and strategies to be successful in their practices, at the firm and in the community. Through discussions, events, networking opportunities and business development training, WAVES strives to enhance our attorneys' abilities and strengthen connections with our clients. Under the direction of the Diversity Committee, WAVES is currently co-chaired by women shareholders across five offices: Amy L. Bess of the Washington, DC office, Blythe E. Lovinger of the New York office, Elizabeth N. Hall of the Chicago office, Michelle L. Landry of the San Francisco office, and Candice T. Zee of the Los Angeles office. The group is also supported by Laurel Dearborn, Director of Associate Development. At Vedder, we endeavor to provide women with the means to make waves and create a significant impact in their professional careers.

To follow through with our commitment to diversity, the firm created the Vedder Price Diversity Scholarship in 2005. The first scholarship was awarded in the fall of that same year. Eligible candidates are first-year law students. In 2016, the firm expanded the Diversity Scholarships to our New York office. Each scholarship includes a \$10,000 monetary award for law school-related expenses, as well as a guaranteed summer associate position in our Summer Associate Program after the scholarship recipient's first year of law school. Vedder Price actively sponsors or is involved in a wide variety of diverse bar and law student affinity organizations, including committing attorney time to mentor diverse law students and their student organizations. We also provide financial support to many such organizations. Vedder Price's Diversity Committee is committed to supporting our attorneys' requests to sponsor affinity group bar associations, legal and public interest organizations, and legal or other conferences and/ or events. In February 2018, Vedder joined the Leadership Council on Legal Diversity (LCLD), an organization of more than 275 corporate chief legal officers and law firm managing partners who have dedicated themselves to creating a diverse U.S. legal profession. Their programs are designed to attract, inspire and nurture talent within organizations, helping a new and more diverse generation of attorneys achieve positions of leadership. As a member of the LCLD Fellows Program, Shareholder David M. Hernandez was named to the 2020 class of Fellows of the Leadership Council on Legal Diversity, and Shareholder Jeanah Park was named to the class of 2019. Launched in 2011, the LCLD's landmark Fellows Program works by identifying high-potential attorneys from diverse backgrounds and setting them on the path to leadership of their organizations. Vedder Price's fellows spend their Fellow Year participating in conferences, interactive leadership events and extensive contact with other members of the LCLD.
