Time to File H-1B Petitions

Dear Clients and Friends—Time to tee up your H-1B petitions! As you know, current U.S. immigration law permits only 65,000 new regular H-B visas to be issued per calendar year. Last year the government "ran out" of H-1B visas as of August 7, 2005, almost two months before the fiscal year began.

As of April 1, 2006, employers may begin to file new H-1B petitions for the next fiscal year, which begins on October 1, 2006. In order ensure that you obtain the H-1b visas you need, we strongly recommend that employers file their H-B petitions as soon as possible. This is of particular importance to employers of students in practical training status. Regardless of the fact that their Employment Authorization Card may be valid until mid-2007, they will not be able to continue working unless an H-1B petition has been filed on their behalf while there are still numbers available. We are anticipating that the government may "hit the cap" and use up all H-1B visas in June 2006. Therefore, please file as soon as possible!

Let's Change That!

Congress is now debating changes to the U.S. immigration laws, some of which will be very beneficial to employers. We urge you to call your U.S. senators and congressional representatives to urge them to vote in favor of comprehensive reform (either the McCain/Kennedy Bill or the Spector Bill). Change in Filing Locations

Effective April 1, 2006, the U.S. Department of Homeland Security/Citizenship and Immigration Service (USCIS) has changed the location where both nonimmigrant (temporary) and immigrant (permanent) work-related petitions should be filed. *All* nonimmigrant petitions will now be filed with the USCIS Service Center in Vermont. All immigrant petitions will be filed with the USCIS Service Center in Nebraska.
