## **Employer Immigration Alert—H-1B Visas**

Employers—please note that all petitions for new H-1B visas should be filed with the U.S. Citizenship and Immigration Service ("USCIS") on APRIL 1, 2008 to ensure that they have a chance of being adjudicated. As you know, the U.S. government limits the number of new H-1B visas for professionals to 65,000 each year, with limited exceptions. Last year, 124,000 H-1B petitions were received between April 1 and April 3, forcing USCIS to develop a lottery selection process to determine which petitions would be adjudicated. This year's demand is expected to be similarly high, and the entire year's supply of H-1B visas is expected to be exhausted on April 1—the first day that petitions may be filed for the 2009 Fiscal Year. If an employer misses the opportunity to petition for a prospective employee this year, the earliest it may employ that person in H-1B status will be October 1, 2009. On March 19, 2008 USCIS issued an interim final rule that prohibits employers from filing multiple H-1B petitions for the same employee. This new rule is designed to ensure that companies filing H-1B petitions have an equal chance of having their petition selected in the lottery process. Please note that in some limited circumstances, related entities may be permitted to file more than one petition on behalf of the same employee.
